PAIGN, THE UNITED BUILDING FUND CAMPAIGN AND OTHER DRIVES HE WAS INSTRUMENTAL IN HELPING TO RAISE MORE THAN \$65,000,000 FOR CHARITABLE PURPOSES.

MR. MARSHALL WAS NOT GREATLY IN SYMPATHY WITH THE ZIONIST MOVEMENT IN PALESTINE. HE ONCE DESCRIBED HIMSELF AS "SOMETHING BETTER THAN A ZIONIST OR A NON-ZIONIST: I AM A JEW." HE WAS MORE SYMPATHETIC AND MORE VIGOROUS IN HIS SUPPORT OF JEWISH COLONIZATION IN RUSSIA THAN IN PALESTINE, ALTHOUGH HE NEVER HESITATED TO OFFER HIS SERVICES FOR THE JEWS IN PALESTINE, AS HE DID FOR JEWS EVERYWHERE.

IN JANUARY, 1927, MR. MARSHALL BECAME A MEMBER OF THE PALESTINE SURVEY COMMISSION, WHICH ENGAGED EXPERTS TO INVESTIGATE CONDITIONS IN PALESTINE AND MAKE REPORTS TO THE COMMISSION, WITH A VIEW TO A CONFERENCE BETWEEN ZIONISTS AND NON-ZIONISTS TO COOPERATE IN ACTING UPON THEIR RECOMMENDATIONS.

THE FRUITION OF THESE EFFORTS, IN WHICH HE WAS ASSOCIATED WITH MANY OTHER PROMINENT JEWS, CAME IN JULY OF 1929, WHEN THE JEWISH AGENCY CAME INTO BEING AT ZURICH, SWITZERLAND, AT A JOINT MEETING OF ZIONISTS AND NON-ZIONISTS.

THE AGENCY REPRESENTED THE FIRST CONCERTED MOVEMENT OF ZIONISTS AND NON-ZIONISTS ACTING IN CONCERT FOR THE RECLAMATION OF PALESTINE, AND IN RECOGNITION OF HIS WORK MR. MARSHALL WAS ELECTED CHAIRMAN OF THE COUNCIL OF THE AGENCY.

ONE OF THE OUTSIDE INTERESTS WAS IN THE CAUSE OF FOREST PRESERVATION. FOR MORE THAN TWENTY YEARS HE WAS PRESIDENT OF THE NEW YORK STATE COLLEGE OF FORESTRY.

MR. MARSHALL WAS A FREQUENT LECTURER BEFORE LEARNED AND PHILANTHROPIC SOCIETIES, FOR MANY YEARS HE WAS CHAIRMAN OF THE COMMITTEE ON THE AMENDMENT OF LAW OF THE BAR ASSOCIATION OF NEW YORK CITY; A MEMBER OF THE AMERICAN LAW INSTITUTE, AMERICAN BAR ASSOCIATION, AS WELL AS THE NEW YORK STATE AND NEW YORK COUNTY BAR ASSOCIATIONS; A LIFE MEMBER OF THE ZOOLOGICAL SOCIETY, BOTANICAL GARDEN, AMERICAN MUSEUM OF NATURAL HISTORY, NEW YORK HISTORICAL SOCIETY, THE ACADEMY OF SCIENCES AND AN HONORARY MEMBER OF PHI BETA KAPPA. THE CLUBS HE BELONGED TO WERE THE LOTOS, BANKERS AND REPUBLICAN.

ON MAY 6, 1895, MR. MARSHALL MARRIED MISS FRANCES LOWEN-STEIN OF NEW YORK. SHE DIED IN MAY, 1916. FOUR CHILDREN SURVIVE: JAMES, A LAWYER, WHO IS CONNECTED WITH THE FIRM OF GUGGENHEIMER, UNTERMYER & MARSHALL; RUTH, NOW MRS. JACOB BILLIKOP, OF PHILA-DELPHIA: ROBERT AND GEORGE.
